## **CONTINUING RELEASE OF LIABILITY AND COMPETITION AGREEMENT FOR THE 2017-2018 SEASON CHILD - 17 AND UNDER**

### **PLEASE READ CAREFULLY!**

I AGREE AND ACKNOWLEDGE ON A CONTINUING BASIS FOR ANY AND ALL SKI OR SNOWBOARD RELATED ACTIVITIES, EVENTS OR COMPETITIONS THAT IN GIVING THIS CONSENT THAT:

- 1) I know there is risk associated with ski/snowboard event(s) or competition(s) and that there is the danger of possible bodily injury or even death. I know also that there is a risk of damage to his/her ski/snowboard equipment and/or his/her clothing by participating in ski/snowboard events or contests.
- 2) I know Nub's Nob's sole function is to provide the ski/snowboard slopes, the event(s) area(s), competition course(s) (if any) and to judge(s)(if applicable) the events.
- 3) I know it is my responsibility to examine the event area(s), contest course(s) and the area(s) around it prior to the event(s) or competition(s) and I agree that he/she will not participate in event(s) or competition(s) unless I am completely satisfied with the safety of the conditions.
- 4) He/she is physically fit and is a proficient ski/snowboarder, fully capable of participating in ski/snowboard competitions and **may use a ski lift without being accompanied by an adult or without an adult present.**
- 5) I agree that Nub's Nob or anyone associated with it will not be liable for any loss, injury or death related to his/her participation in these activities. I hereby release all of them from any and all liabilities and agree not to bring any suit for injuries or damages relating to these activities. I will defend and indemnify Nub's Nob for any loss or damage, including any that results from claims or lawsuits for personal injury, death and property loss and damage relating in any way to these activities.

### **PARENT/GUARDIAN HOLD HARMLESS AND INDEMNITY CONTRACT**

6) I, parent/guardian, agree to indemnify and hold harmless Nub's Nob, its employees, any agents or representatives, officers, directors or anyone affiliated with or entity associated with them from any and all claims of any nature as may be brought in the name of or in behalf of the child/minor identified in this document. I specifically agree to indemnify and hold harmless the parties herein identified from any liability whether known or unknown even if that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

7) I acknowledge that I have read the Skier/Snowboard Responsibility Code and understand the responsibilities it imposes upon participants in this inherently dangerous sport.
